BOARD ADMINISTRATION

On motion by Director MENDONSA, second by Director GARCIA and unanimously approved, the agenda was approved as presented.

On motion by Director GARCIA, second by Director TRISTAO, and unanimously approved, the minutes of the July 11, 2023, meeting were approved as presented.

LIMAS updated the Board on ET and Transitional water usage. No action was taken.

LIMAS reviewed the determination letter from California Department of Water Resources and the State Water Resources Control Board process on the Groundwater Sustainability Plan of the Tule Sub basin. LIMAS gave an update on meetings held between the Tule Subbasin and SWRCB staff and progress being made to analyze needed GSP revisions. No action was taken.

LIMAS reported on the final LandFlex award the District received from DWR based on landowner applications. No action was taken.

SUSAN LONG, Executive Director of the Tule Subbasin Land and Water Conservation Trust reviewed Multibenefit Land Repurposing Grant activities and the 2023/2024 Trust Land Fallowing program. The Trust submitted a request to the LTRIDGSA to participate in the land fallowing program. After discussion, on motion by Director MENDONSA, second by Director TRISTAO and unanimously approved, the Board approved up to \$200,000 in matching funds for acres fallowed within Lower Tule.

There being no further business to be brought to the Board attention, and the meeting was adjourned.
