The Board of Directors of the Pixley Irrigation District met in a regular meeting on the 10th day of June, 2010 at 9:00 a.m. at the District office in Tipton, California.

BOARD ADMINISTRATION

On motion by Director R.L. Westbrook, second by Director DeGroot and unanimously approved, the Agenda was approved as presented. Including in the agenda was notice of a tour that the Board will take of District Operations and facilities away from the office.

The minutes of the May 12, 2010 Regular meeting were distributed for review prior to the meeting. On motion by Director Junio, second by Director Schott and unanimously approved, the minutes of the May 12th regular meeting were accepted by the Board and ordered placed on file.

The Financial Statements for the month of May were reviewed. On motion by Director DeGroot, second by Director Junio and unanimously approved, the Board

accepted the Financial Statements and ordered them placed on file.

At approximately 9:30am Paul Klippenstein entered the meeting to review with the Board the 2009 audited financial statements.

The Board reviewed the 2009 audited financial statements and spent considerable time discussing them with Auditor Paul Klippenstein. On motion by Director Junio, second by Director DeGroot and unanimously approved the Board accepted the audited financial statements and ordered them placed on file.

The Board reviewed the actions of the Finance Committee in the payment of the May bills prior to the meeting. On motion by Director DeGroot, second by Director Schott and unanimously approved the Board ratified the actions of Finance Committee in the payment of the bills.

WATER RESOURCES

General Manager Vink reviewed a variety of water resources activities including the current declaration and the projected water supply.

At present the District is not running water and will stay off until the summer water run starts up the 7th of July. The preliminary water supply available to the District should allow the District to run through July with the run ending approximately mid August. Additional water supply information will be available at a subsequent meeting.

General Manager Vink pointed out that the Bureau could resume the uncontrolled season operations on the Friant system, which would mean the District would have an additional short run sometime between the current date (June 10th) and the resumption of a planned summer run on July 7th.

General Manager Vink reviewed the Cross Valley canal deliveries for 2010. Given the above normal projected deliveries on the Westside, there is not much of a market for the CVC water in 2010. General Manager Vink is working on a sale of a portion of the Districts CVC water albeit at a reduced price from past years.
